Environmental Choice New Zealand is the New Zealand Ecolabelling Trust's voluntary, multiple specifications based environmental labelling programme. It operates to international standards and principles. Initiated and endorsed by the New Zealand Government, Environmental Choice recognises the genuine moves made by manufacturers to reduce the environmental impacts of their products, and provides a credible and independent guide for consumers who want to purchase products that are better for the environment.



To achieve carbon neutrality certification under the NCOS Carbon Neutral Program, an entity must measure its carbon footprint, reduce emissions where possible, and purchase NCOS eligible abatement to offset the remaining emissions. The entity must also develop a plan for management of emissions which includes the management framework, systems, and processes in place to effectively manage the carbon neutral commitment from start to end, as well as prepare a summary of emissions and actions under the program for public disclosure. All of these activities must be independently verified.



The Australasian Furnishing Research and Development Institute (AFRDI) is an independent not-for-profit technical organisation providing standards, testing, product certification and research for buyers and sellers of furniture. AFRDI Blue Tick certification is granted to suppliers whose products meet the required standard – in our case AS/NZS 4433:1997:2005 height adjustable swivel chairs. Good Environmental Choice Australia is the voluntary environmental labelling standard developed by GECA and is a scientifically recognised benchmark for environmental performance. GECA has mutual recognition with the Green Seal (USA) and Blue Angel (Germany) ecolabelling programmes and is a member of the Global Eco-labelling Network (GEN), which includes Euro Flower (EU) and Environmental Choice NZ ecolabelling programmes.



Programme for the Endorsement of Forest Certification is a scheme for auditing forestry operations, taking into account the effects on the environment. Paper that is totally derived from resources which are managed to ensure their renewability for generations to come. Elementally Chlorine Free pulp is bleached using processes that do not use elemental chlorine gas, reducing significantly the amount of toxins released. The international standard that guarantees paper for archiving.



GREENGUARD is one of the world's most respected environmental certifications. It certifies that product chemical emissions are at safe levels, in view of minimising indoor air pollution and potential chemical exposure. Scientifically tested for chemical emissions. Products certified to GREENGUARD Gold undergo rigorous scientific testing in the USA to meet some of the world's most stringent chemical emissions requirements. Components and complete products are tested. More than 360 chemicals are assessed and 10,000 chemicals are screened for.



Green Tag is the National Certification mark in Australia and New Zealand for the Green Building Council, a recognised third party certifier. Green Rate and LCA Rate certifications combined make Green Tag one of the world's best product certification schemes. Green Rate indicates you can trust that products certified to A, B, or C level are healthy and eco-friendly having been certified based on their toxicity and emissions, resource efficiency, durability, and corporate social responsibility.
